A BILL

To amend the Clean Air Act to deny entry into the United States of certain foreign motor vehicles that do not com-

ply with State laws governing motor vehicle emissions, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Border Smog Reduction*
5 *Act of 1998”.*

6 **SEC. 2. AMENDMENT OF CLEAN AIR ACT.**

7 *Section 183 of the Clean Air Act (42 U.S.C. 7511b)*
8 *is amended by adding the following new subsection at the*
9 *end:*

10 *“(h) VEHICLES ENTERING OZONE NONATTAINMENT*
11 *AREAS.—*

12 *“(1) AUTHORITY REGARDING OZONE INSPECTION*
13 *AND MAINTENANCE TESTING.—No noncommercial*
14 *motor vehicle registered in a foreign country and op-*
15 *erated by a United States citizen or by an alien who*
16 *is a permanent resident of the United States, or who*
17 *holds a valid visa for purposes of employment or edu-*
18 *cational study in the United States, may enter a seri-*
19 *ous, severe, or extreme ozone nonattainment area from*
20 *a foreign country bordering the United States and*
21 *contiguous to such nonattainment area more than*
22 *twice in a single 12-month period, if State law has*
23 *requirements for the inspection and maintenance of*
24 *such vehicles under the applicable implementation*

1 *plan in the nonattainment area. The preceding sen-*
2 *tence shall not apply if the operator presents docu-*
3 *mentation at the United States border entry point es-*
4 *tablishing that the vehicle has complied with such re-*
5 *quirements that are in effect and are applicable to*
6 *motor vehicles of the same type and model year.*

7 “(2) *SANCTIONS FOR VIOLATIONS.—The Presi-*
8 *dent of the United States may impose and collect*
9 *from the operator of any motor vehicle who violates,*
10 *or attempts to violate, paragraph (1) a civil penalty*
11 *of not more than \$200, except that in any case of re-*
12 *peated violations or attempted violations such penalty*
13 *may not exceed \$400.*

14 “(3) *STATE ELECTION.—The prohibition set*
15 *forth in paragraph (1) shall not apply in any State*
16 *which elects to be exempt from the prohibition. Such*
17 *election shall take effect upon the President’s receipt*
18 *of written notice from the Governor of the State noti-*
19 *fying the President of such election.*

20 “(4) *STATE ELECTION FOR OTHER NONATTAIN-*
21 *MENT AREAS.—*

22 “(A) *IN GENERAL.—In the case of a State*
23 *that is contiguous with a foreign country and*
24 *that contains an ozone nonattainment area*
25 *(other than an ozone nonattainment area to*

1 *which paragraph (1) applies), such State may*
2 *elect for the prohibition described in such para-*
3 *graph to apply in the State, or may elect to es-*
4 *tablish in accordance with subparagraph (B) an*
5 *alternative approach to facilitate the compliance,*
6 *by motor vehicles registered in foreign countries*
7 *and entering such nonattainment area, with the*
8 *motor vehicle inspection and maintenance re-*
9 *quirements in effect under the applicable imple-*
10 *mentation plan in the nonattainment area and*
11 *applicable to motor vehicles of the same type and*
12 *model year.*

13 “(B) *ALTERNATIVE APPROACH.*—*An alter-*
14 *native approach by a State under subparagraph*
15 *(A) is established in accordance with this sub-*
16 *paragraph if the Governor of the State submits*
17 *to the President a written description of such ap-*
18 *proach and the President approves the approach*
19 *as facilitating compliance for purposes of such*
20 *subparagraph.*

21 “(C) *EFFECTIVE DATE REGARDING STATE*
22 *ELECTION.*—*If a State makes an election under*
23 *subparagraph (A) for an alternative approach,*
24 *the alternative approach takes effect in the State*
25 *one year after the date on which the President*

1 *approves the approach. If the State makes the*
2 *other election under such subparagraph, the pro-*
3 *hibition described in paragraph (1) takes effect*
4 *in the State 180 days after the President’s re-*
5 *ceipt of written notice from the Governor of the*
6 *State notifying the President of such election.*

7 “(5) *ALTERNATIVE APPROACH REGARDING SERI-*
8 *OUS, SEVERE, AND EXTREME AREAS.—In the case of*
9 *a State containing an ozone nonattainment area to*
10 *which paragraph (1) applies, paragraph (4) applies*
11 *to the State to the same extent and in the same man-*
12 *ner as such paragraph applies to States described in*
13 *such paragraph, subject to paragraph (3).*

14 “(6) *DEFINITION.—For purposes of this section,*
15 *a serious, severe, or extreme ozone nonattainment*
16 *area is a Serious Area, a Severe Area, or an Extreme*
17 *Area as classified under section 181, respectively,*
18 *other than any such area first classified under such*
19 *section after the date of the enactment of the Border*
20 *Smog Reduction Act of 1998.”.*

21 **SEC. 3. GENERAL PROVISIONS.**

22 “(a) *IN GENERAL.—The amendment made by section*
23 *2 takes effect 180 days after the date of the enactment of*
24 *this Act. Nothing in such amendment shall be construed to*

1 *require action that is inconsistent with the obligations of*
2 *the United States under any international agreement.*

3 (b) *INFORMATION.*—*As promptly as practicable follow-*
4 *ing the enactment of this Act, the appropriate agency of*
5 *the United States shall distribute information to publicize*
6 *the prohibition set forth in the amendment made by section*
7 *2 and its effective date.*

8 **SEC. 4. STUDY BY GENERAL ACCOUNTING OFFICE.**

9 (a) *IN GENERAL.*—*The Comptroller General of the*
10 *United States shall conduct a study of the impact of the*
11 *amendment made by this Act, as described in subsection*
12 *(b).*

13 (b) *CONTENTS OF STUDY.*—*The study under subsection*
14 *(a) shall compare the potential impact of the amendment*
15 *made by this Act on air quality in ozone nonattainment*
16 *areas affected by such amendment with the impact on air*
17 *quality in the same areas caused by the increase in vehicles*
18 *engaged in commerce operating in the United States and*
19 *registered in, or operated from, Mexico, as a result of the*
20 *implementation of the North American Free Trade Agree-*
21 *ment.*

22 (c) *REPORT.*—*Not later than July 1, 1999, the Comp-*
23 *troller General of the United States shall submit to the Com-*
24 *mittee on Commerce of the House of Representatives, and*
25 *the Committee on Environment and Public Works of the*
