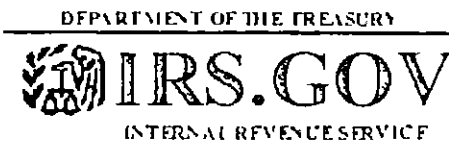

In Notice 2002-34, the Internal Revenue Service (IRS) introduced a voluntary compliance program for political organizations that have not met the reporting requirements enacted in July 2000. Our records indicate that you filed Form 8871, *Political Organization Notice of 527 Status*, in writing. As of April 30, 2002, we do not have any record that you filed Form 8872, *Political Organization Report of Contributions and Expenditures*.

Unless it meets one of the exceptions, a political organization must file Form 8871 both electronically and in writing within 24 hours of the date the organization was established. The requirements and exceptions are discussed in the enclosed Notice 2002-34. Any such organization that fails to file timely both electronically and in writing will be treated as a taxable political organization until both forms are filed as required.

A political organization must also periodically file Form 8872, unless it meets one of the exceptions, to disclose information concerning expenditures made and contributions received. These requirements and exceptions are also discussed in the enclosed Notice 2002-34. A political organization that does not disclose this information must pay an amount equal to the highest corporate tax rate (35 percent) multiplied by the amount of contributions and expenditures not disclosed and report this on the Form 1120-POL.

If you filed Form 8871 electronically and Form 8872 prior to April 30, 2002, please inform us so we may correct our records. Please provide us with the date(s) you filed, the exact name and EIN used, and any other information that may help us resolve this issue. If you have not yet filed Form 8871 electronically or Form 8872, you will not be assessed any tax, penalty or interest due to a late filing to the extent you do so by July 15, 2002. You may electronically file Form 8871 on the IRS website at <http://www.irs.gov/pologs>. Form 8872 is also available on that site and must be sent to the Ogden Service Center in accordance with the instructions.

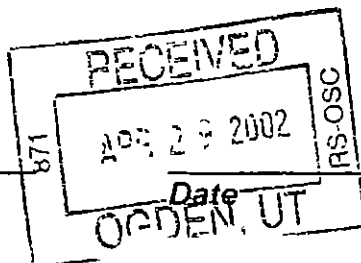

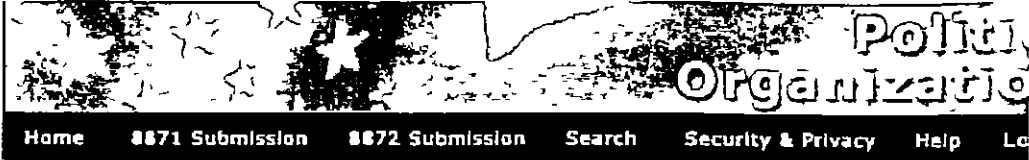
